# Essex Historic Environment Record

April 2017 – March 2018



## Introduction & service specification

The Essex Historic Environment Record (HER) is a complex GIS- based database, and associated material, containing information on a wide range of buildings, monuments, find spots, places, and landscapes of archaeological, architectural, artistic or historic interest. Historic Environment Record (HER) searches provide information selected from the record, normally for a defined area, although bespoke searches can also be completed e.g. for particular periods or types of records.

The HER includes both digital and hard copy information and references to other sources held outside the HER. It is constantly being up-dated and enhanced, but the absence of a record should not be relied upon as indicating an absence of heritage significance at any given location. Other national specialist sources may contain information not currently held or indexed.

For personal research core HER information may be found online at [unlockingessex.essexcc.gov.uk](http://unlockingessex.essexcc.gov.uk) and at [www.heritagegateway.org.uk](http://www.heritagegateway.org.uk). This data will only include a summary of the full HER, and should not be relied upon to be complete or up-to-date. HER searches undertaken in support of planning applications, and for other commercial purposes, must be directed to the Historic Environment Advisors at Place Services.

HER searches take two forms:

- Remote searches that involve the supply of digital data by Places Services.
- HER visits that involve a personal visit to view the HER.

### Remote searches

Place Services aims to respond to HER search requests within 10 working days. Where a rapid turnaround is required a **priority search** is normally available with a response within three working days, although this will be charged at an additional cost. ### Charges

Charges are levied for a license to re-use HER information for commercial purposes, and planning applications. The level of charge depends on the number of records within the search area. The schedule of charges is set out in Table 1, on the next page.

### Data format

Data supplied will be in the following formats:

- Monument and Event Records (PDF report)
- Map data as ArcGIS shapefiles (Monument polygons, polylines and points; Event polygons and points) will incur additional costs
- Historic Environment Characterisation (PDF report) Provision
- PDF copy of Essex HER map data
- Aerial photographic NMP plots (rectified hand and/or digitized plots)
- PDF copies of specific reports within the study area.

### Designated Heritage Assets

Contractors and consultants wishing to obtain bulk copies of spatial data for designated heritage assets are encouraged to obtain the definitive datasets from Historic England. These can be down-loaded from: <http://services.historicengland.org.uk/NMRDataDownload/> Conservation Area documents can be obtained from the relevant District or Borough councils' websites.

### Non-commercial HER searches

For non-commercial HER searches, a discretionary charging policy applies. Non-commercial enquirers should contact Place Services to discuss their requirements.

### HER visits

HER visits must be booked in advance and are only necessary in order to view material available in hard copy only. Our Historic Environment Advisors will endeavour to assist in establishing whether a visit is required, but are unable to undertake a detailed assessment of the relevance of any particular data or information.

Information that can be accessed (where held in the HER) includes:

- Designation documents
- Oblique and vertical aerial photos
- Relevant historic mapping; geological maps
- Photographs of Heritage Assets
- Published sources
- Contractors' and other fieldwork reports (these are largely available as PDF files)
- Conservation/Management plans.

The images supplied as part of an HER search must not be published without prior permission, and may incur a further publication charge.
