


### Formation of the Garden Town Project

- Gained formal Government Garden Town Status in January 2017
- Awarded Garden Town Capacity Funding and Planning Delivery Funding
- GT strategic sites are allocated by three Local Plans










### Garden Town Board

- Meets every other month
- Has a newly appointed Independent Chair
- Is composed of multiple partners
- Does not currently have formal decision making powers
- Delivery model options are being explored and considered



### The Garden Town Team

- GT Team being formed to act on behalf of all five GT authorities
- Co-located team
- GT Officer Board meets every 5-6 weeks comprised of officers from all GT authorities
- Preparing joint work to enable the authorities to bring forward the GT in a cohesive and comprehensive way

A central position in the LSCC - one of the fastest growing regions in the country. The Garden Town was the birth place of fibre optics and can continue to play a significant role in future growth of the region.

Green environment and New Town optimism - the existing town has a wonderful Green Wedge network and Stort Valley setting.



Arrival of Public Health England - £400 million will be invested in New Frontiers Science Park, with 3,500 new jobs introduced to the town.



Harlow Enterprise Zone - planned investment in three sites covering 72 acres, contributing to more than 5,000 potential jobs over a 25 year period.



An extensive cycle network - making use of Harlow's existing network and transforming this so it is comfortable for all users.



# Transport Strategy

- Fundamental guiding principals are modal shift, the mobility hierarchy, and ensuring sustainable journeys are efficient and safe.
- Mobility options hierarchy:
- 1) Reduce the need to travel
- 2) Walking and cycling
- 3) Public transport
- 4) Private vehicle use.



Harlow is the home of fibre-optic technology.






